PBA UPDATE

Once again, another cop-killer is coming up for parole. Salvatore “Crazy Sal” Desarro, killer of 69 Precinct P.O Cecil Sledge. The organization is looking for help to keep Desarro behind bars. To date, the out-of-control New York State Parole Board has released thirty-four cop-killers in a little over four years.

Remember Police Officer Sledge! He was working a solo-unit and made a traffic Stop at Flatlands Avenue and 78th Street in Brooklyn (January 28, 1980.) He recognized The subject as being wanted in connection to a robbery that occurred the previous day. As he approached the vehicle, Sledge was shot and as he fell to the ground, his gun belt became entangled on the car, and he was dragged approximately one-quarter mile before falling free.

Officer Sledge was a U.S. Army veteran and had been a cop for 12 years. He was only 35 years old and left behind a wife and two children. Because of Sledge’s death, the Department stopped “one man” cars except those where members carried a shot-gun.

The subject, who had been out on parole, was apprehended after taking an elderly women hostage in her own home. Desarro was convicted for second-degree murder and sentenced to 25 years to life. He has been denied parole in September 2014 and again in September 2016.
